

**2017 Property Tax Rates in VICTORIA COUNTY GROUND WATER
CONSERVATION DISTRICT**

This notice concerns the 2017 property tax rates for VICTORIA COUNTY GROUND WATER CONSERVATION DISTRICT. It presents information about three tax rates. Last year's tax rate is the actual tax rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers start rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

This year's rollback tax rate:

Last year's adjusted operating taxes (after subtracting taxes on lost property and adjusting for any transferred function, tax increment financing, state criminal justice mandate, and/or enhanced indigent healthcare expenditures)	\$623,878
÷ This year's adjusted tax base	\$7,114,276,098
=This year's effective operating rate	\$0.00876/\$100
x 1.08 =this year's maximum operating rate	\$0.00946/\$100
+ This year's debt rate	\$0/\$100
= This year's total rollback rate	\$0.00946/\$100

Statement of Increase/Decrease

If VICTORIA COUNTY GROUND WATER CONSERVATION DISTRICT adopts a 2017 tax rate equal to the effective tax rate of \$0.00876 per \$100 of value, taxes would increase compared to 2016 taxes by \$5,404.
