Topic 7.2 - TWDB GAM Development for GMA 15

Administrator Discussion: Mr. Andruss explained that on September 1, 2020, groundwater management districts within GMA 15 and GMA 16 were notified of a stakeholder meeting regarding TWDB's effort to develop a new groundwater availability model (GAM) for central and southern Gulf Coast Aquifer. The stakeholder meeting was held on September 29, 2020. The deadline for submitting comments on the conceptual model was originally set as October 16, 2020.

TWDB has expressed a willingness to accept comments after the October 16, 2020 deadline.

VCGCD, RGCD, TGCD, and CCGCD have agreed to share the costs for having a technical review of the conceptual report completed. These districts anticipate having the technical review completed and submitted to TWDB by January 2021.

Established a subcommittee composed of Mr. Andruss and Mr. Van Dresar to serve as a liaison to GMA 16.
